**S.R.O. 983 (I)/93.** -In exercise of the powers conferred by sub-section (1) of section 3 of the Imports and Exports (Control) Act, 1950, (XXXIX of 1950), the Federal Government is pleased to direct that following further amendments shall be made in Import Policy Order 1993, namely: -

#### **CHAPTER-1**

**S.R.O. 989 (I)/93.** - In exercise of the powers conferred by section 29 of the Seed Act, 1976 (XXIX of 1976), read with section 10 thereof, the Federal Government is pleased to make the following amendments in the Seed (Truth-in-Labeling) Rules, 1991, namely:-

In the aforesaid Rules;-

- (a) rule 8 shall be renumbered as sub-rule (1) thereof and after sub-rule (1) renumbered as aforesaid, the following new sub-rules shall be added, namely:-
  - "(2) Import of seed of only those varieties shall be allowed which have been approved by the Agriculture Research Institutes and entered and notified by the Federal Government in the National Register for seed and crop production in Pakistan.

- (3) National Seed Registration Agency shall ensure supply of a copy of the National Seed Register and updating it periodically.
- (4) A small packet of seed not exceeding experimental quantity upto 10 kg.

  may be allowed to be imported subject to the approval by the Ministry of
  Food and Agriculture.
- (5) The importer shall inform the Federal Seed Certification Agency on the application Form given in Schedule-IV, the probable date of arrival of the seed and other seed propagating material at the port of entry and shall on arrival of the seed and seed propagating material notify to the Federal Seed Certification Agency on the Form given in Schedule-V for drawing of samples for testing etc."
- (b) in Schedule-II at the end the following shall be added namely:-

#### "Flower seeds:-

Purity (minimum)	98%
Inert matter (maximum)	2.0%
Other crop seeds and weed seed (maximum)	0.0%
Objectionable weeds (maximum)	0.01%
Germination (minimum)	65%
